# **Primary Care Inquiry**

# What should Primary Care look like for the next generation?

# Two-part inquiry:

- 1<sup>st</sup> phase hearing from service users across Scotland.
- 2<sup>nd</sup> phase hearing from the professions, including seeking their views on what the public have told us.





- The National Clinical Strategy for Scotland, which signals the transformation required in Primary Care.
- The Government's vision for the future of primary care services is to be multidisciplinary teams, of a variety of health professionals, working together to support people in the community - and free up GPs to spend more time with those patients in specific need of their expertise.
- A new Scottish General Medical Services Contract Offer agreed in 2018, which notes that the "non-expert medical generalist workload needs to be redistributed to the wider primary care multi-disciplinary team".



#### Phase 1

#### March - June 2019

Views and experiences from the public and especially people who use primary care services across Scotland.

- Online survey 2,549 responses, March and April 2019
- Scottish Youth Parliament Survey 1,136 responses
- Three public panels Dunfermline, Cambuslang and Inverurie
- Quantitative and Qualitative data






