Job title: Policy and Research Officer (Scottish Community Link Worker Network)

**Reporting to:** Network Development Coordinator (Scottish Community Link Worker Network)

Salary: £16,800 (equivalent to £28,000 full-time)

Hours: 21 per week

**Flexible location:** 18 York Place, Edinburgh EH1 3EP and/or home working (to be agreed with the successful applicant).

**Benefits:** 15 days annual leave, 6 public holidays and floating days, 6% pension contribution, death in service insurance.

Contract: 12 months initially, with potentially a further 12 to 24 months, subject to funding.

Secondment possibility: VHS is open to offering this post on a secondment basis.

#### Who we are

VHS is the national voice, intermediary and network for voluntary health organisations in Scotland. We work with our members and others to address health inequalities and to create better health and wellbeing for people and communities. Our purpose is to create a healthier, fairer Scotland served by a thriving voluntary health sector. We are a registered Scottish charity and a company limited by guarantee, governed by our Board of Trustees/Directors.

## The Scottish Community Link Worker Network

Since April 2021, VHS has been funded by Scottish Government's Primary Care Directorate to support the establishment of the Scottish Community Link Worker Network, which is a national network for primary care community link working in Scotland. The Network's aim is to create a space for community link workers in primary care settings in Scotland to come together to share learning and to develop, network and support each other in order to improve outcomes for their patients and communities. The network has a number of key objectives:

- Provide a forum to enable peer-to-peer support for primary care community link working across Scotland
- Raise awareness of the community link worker role in tackling health inequalities
- Strengthen the contribution of community link workers to primary care teams and enable greater understanding of community link working within primary care settings
- Identify and maximise training, learning and development opportunities to professionalise the community link worker role

• Provide a collective voice to influence policy regarding community link working

The Network is supported by an advisory group of CLW Programme Leads from NHS Boards and Scottish Government and a working group of Community Link Workers.

#### Purpose of role

The Policy and Research Officer is a new role, designed to further develop and strengthen the profile, capacity, impact and influence of the Scottish Community Link Worker Network. The role will champion the community link worker agenda at a national level and be a resource that supports and enables the Network to engage with policy opportunities.

#### Key results areas

- 1. Identify and maintain awareness of current and future developments in policy and practice, and assess the relevance for community link workers (including mental health link workers) and for their work with patients, primary care and their community.
- 2. Gather and communicate evidence, expertise and perspectives to the development of national policy. Develop and maintain relationships with key stakeholders in the Scottish Government and Scottish Parliament.
- 3. Prepare and submit consultation responses and parliamentary evidence, and contribute to policy working/advisory groups.
- 4. Support the Scottish Community Link Worker Network to identify shared strategic policy and practice priorities for research, evaluation, evidence gathering and data collection relevant to link working.
- 5. Carry out small research projects directly and/or commission research.
- 6. Contribute to external stakeholders' research projects, for example as co-investigator or research steering group member.
- 7. Actively engage the Scottish Community Link Worker Network in relevant policy and public affairs work, using a wide range of communication methods, including face to face, written and digital.
- 8. Produce high quality reports, infographics and summaries for partner and public consumption on policy and practice developments relevant to link working
- 9. Take responsibility for administration of own work and communications, including electronic filing, data input to Salesforce (VHS relationship management system), and posting content to website and social media.
- 10. Be actively committed to your own development and learning. Contribute constructively at your support and appraisal meetings.
- 11. Be a collaborative, supportive and flexible team player. Carry out other tasks and duties as required.
